STORAGE AND STABILITY

FAM-AEVD-FMK Reagent is stable for 18 months when stored at 2°C - 8°C and protected from light. When reconstituted to 150X, store FAM-AEVD-FMK stock at or below -20°C for 6 months protected from light. When diluted to 5X, use FAM-AEVD-FMK immediately. FAM-AEVD-FMK reagent is light sensitive. It will not decompose in a hazardous manner. Hazardous polymerization will not occur.

HEALTH HAZARD

May enter the body through inhalation, ingestion, and skin and eye contact.

SAFETY CONTROL MEASURES

Gloves and standard laboratory protective clothing and eyewear are recommended. Safe laboratory practices should be followed.

EXPOSURE GUIDELINES

FIRST AID MEASURES

Avoid prolonged exposure. Remove contaminated clothing and shoes, and wash before reuse.

Skin:	Wash thoroughly with soap and water for at least 15 minutes. Launder contaminated clothing and shoes.
Eyes:	Immediately flush with water for 15 minutes.
Ingestion:	If conscious, give large amounts of water, seek medical advice.
Inhalation:	Remove to fresh air. If not breathing, administer CPR. If breathing is difficult, give oxygen, seek medical advice.

FIRE/EXPLOSION HAZARD

FAM-AEVD-FMK Reagent is not a fire hazard nor an explosion hazard. Use any means suitable for extinguishing surrounding fire. It is not necessary to use any special firefighting procedures. Water spray, carbon dioxide, dry chemical powder or appropriate foam can all be used.

ACCIDENTAL RELEASE MEASURES
